- *Electronic or Video Game Consoles*

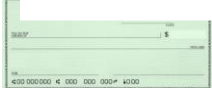
**ATTENTION!**

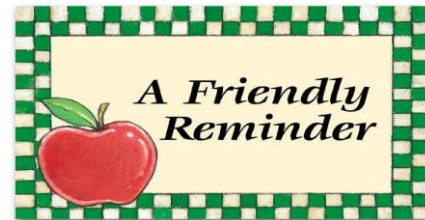

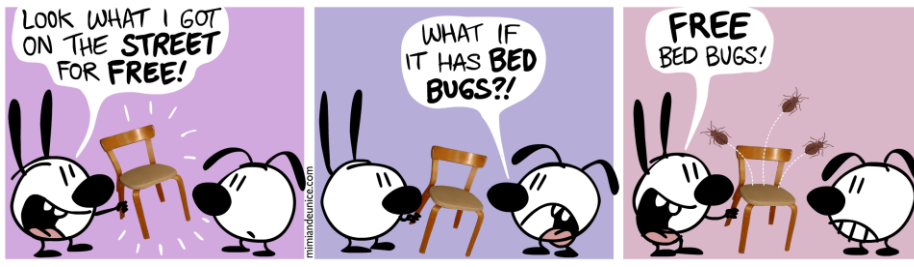

One piece of this is that there will be on-site security during the summer months at the Family Sites for the next 2 years.
